




## Giant UFO in the Yukon Territory



On December 11, 1996, at least 31 people in the Yukon Territory of Canada witnessed a giant UFO. Indications are that it may have been the size of several football stadiums. The sightings principally took place in four locations in the central Yukon; Fox Lake, the Village of Carmacks, the Village of Pelly Crossing, and the Village of Mayo with 6, 9, 8 and 8 witnesses respectively.

..This is an exemplary report of an immensely large UFO seen by many people. I compare the Belgian sightings, in a small corner of a small country, with the Yukon sightings, in a very large corner of a very large country.



Fox lake, Yukon Territory.




Some observers were at the end of Fox Lake, looking North.




Figure 34. FOX3 estimates the angular size of the UFO while on site at the UFO sighting location. The geometry between his eyes and the tip of his hands was measured and used to calculate the UFO size. His cousin (FOX2) was 570 metres (1870 ft) ahead of him during the UFO sighting and was directly underneath the edge of the UFO. This information was used to obtain a UFO size of 1.7 km (1.1 miles) in length.






Martin Jasek interviewed over 30 witnesses, most of them independent, and got detailed reports from many of them. This is his computer-generated illustration of the low, big and slow UFO, as reconstructed from the individual witness reports.


The ET equivalent of a Carnival Cruise Line ship, looking in on the natives.



Another thoroughly studied low, big and slow case: the full report was prepared by Glen Schulze and Robert Powell of MUFON. They had access to FAA radar tapes, which they knew how to analyze. The USAF did not share radar with them, but they obtained civilian data through Freedom of Information requests.



We cannot control the comings and goings of the entities or of the machines.


We private citizens do not know why they are here or where they come from.

And the gentle public reaction — epitomized by cartoonists' treatments— is to make light of the concern, but not to scold. By joking, we manage to replace anxiety with humor, which is an easier attitude to adopt towards the whole problem. And as here, to just admit — we don't understand it. That is easier than agreeing that:

- 1. Some UFOs are extraterrestrial vehicles.
- 2. Some of those ET vehicles have crews.
- Some of those ET crews "catch and release" humans to study us.

..... Which is my conclusion, based on the evidence.
